TYPES OF VERIFICATION/SOURCES OF PROOF

Listed below are examples of types of proof - you do not need to provide every document listed. If you have other types of proof not listed, please call your case worker.

Identity

- o Driver's license or Identification card
- o Photo ID (from government agency, school, etc.)
- o Passport
- USCIS (INS) documents
- o Tribal Identification

Proof of Indian (original documents required)

- o Tribal Identification
- o Certificate of Indian Blood
- o Statement from Tribe proving enrollment or descent

Birth/Citizenship (original documents required)

- o Birth certificate
- o Social Security Card
- o U.S. Passport
- Certificate of naturalization
- o Baptismal certificate (with date and place of birth)
- o Statement of witness to birth

Immigration Status (non-citizens)

- o Immigration papers/forms/cards (copy of both sides)
- Other proof from immigration (USCIS), such as:
- o Work authorization, letter of decision or court order

Income

- o 30 days of paycheck stub(s)
- o Letter from employer with Net pay, hours worked
- Copy of child support check or payment stub
- Benefits award letter (Social Security/ Veterans/Unemployment/Disability, Alimony, etc.)
- Self-employment tax forms (IRS Schedule C, etc.)
 Receipts for work expenses if you are self-employed
- Receipts for work expenses if you are self-emp
 School grants/scholarship/loans/financial aid statements
- Sponsor statement form

Per Capita/Revenue Sharing

- Check stub(s)
- o Letter from enrolled with name/amount/date received

Unemployment Benefits Application

- o Completed Application
- o Confirmation page that applicant applied
- Benefits Award/Denial Letter

Property/Resources

- o Bank statements
- Vehicle registration/vehicle insurance
- Proof of loans or debts/liens on property
- Statement of joint ownership
- Mortgage bill(s) or Property deed
- $\circ \quad \text{Life insurance policy, stocks, bonds, IRAs}$
- Most recent retirement account statement(s)
- o Sponsor statement form
- o Settlements such as lawsuits and insurance claims

Relationship and Linkage

- Marriage certificate (death certificate?)
- o Domestic partner certificate
- o Birth certificate
- o Court documents (guardianship, divorce, etc.)
- o Tribal Documents
- Notarized letter with supporting docs

Housing and Utility Costs

- o Rental/lease agreement or rent receipts
- Utility bill (water, gas or electric) (trash?)
- Hotel/motel receipt
- o Cancelled checks or copies
- o Statement explaining housing arrangement

Residence

- Utility bill (water, gas or electric) (trash?)
- o Rental/lease agreement
- o (Any bill?) Bill with your name and address
- o Driver's license or Identification card (any state?)
- o Eviction notice/notice to pay rent or quit
- o Postmarked envelope or postcard addressed to you
- o Statement explaining housing arrangement

Food Stamps

- o Benefits/Commodities Award Letter
- Current Online Transaction History
- Verification form from County

Medical Verification

- Medical cards
- Health or dental insurance policies or premiums
- Proof of pregnancy from doctor or clinic, with expected due date
- o Doctor statement or disability finding by an agency
- o (SSA/SDI/VA, etc.)
- o Medical verification form from County

Immunization Records (non-school aged children)

- Stamped shot record/Immunization card
- o Statement that immunizations are against your beliefs
- Statement from parent or caretaker relative explaining why you can't get immunizations

Other Proof

- Child/dependent care receipts
- o Statement from child/dependent care provider
- o Receipts for school expenses
- o Cancelled check for child/spousal support payments
- Court papers (child support or spousal support order)
- School attendance records

School Enrollment

- Current report card/ transcripts
- o Current school attendance record
